Ordinary resolution for AGM #1

The Board of Directors and General Committee of the club propose that rule 3.3 and Rule 3.4 relating to retired membership categories be clarified to reflect practice by the inclusion of additional wording as shown in red below.



- 3.3 Retired Single Members Retired Single Membership is open to any individual who is eligible for a State Pension and who has been a Member for at least 10 continuous years directly preceding their application. Retired Single Members are Voting Club Members with the right to attend and vote at General Meetings in accordance with the Articles and the Companies Acts. Retired Single Members may upon application pay such reduced subscription as may from time to time be approved by the General Committee. In the absence of any such reduced rate, Retired Single Members shall pay the annual subscription and other fees determined and approved by the General Committee.
- 3.4 Retired Family Members Retired Family Membership is open to a family grouping which consists of two adults both of whom (i) are eligible for a State Pension and (ii) have been Members for at least 10 continuous years directly preceding their application. For the avoidance of doubt this category of membership cannot include any person who would be eligible for Junior Membership or Student Membership. The retired family grouping will pay a single retired family subscription. The person who pays the subscription will be the "lead Member" and will be a Voting Club Member but another member of that retired family grouping can instead be nominated by the members of that family grouping as the "lead Member" instead of the person who pays the subscription. The other member of the retired family grouping will be an Associate Club Member. Only the lead Member will be a Voting Club Member and, as such, will have and may exercise all the rights and privileges of Voting Club Membership. For the avoidance of doubt, only the lead Member will have the right to receive notice of, and to attend and vote at, any General Meeting but the other member of that retired family grouping have the right to attend any General Meeting. Retired Family Members may upon application pay such reduced subscription as may from time to time be approved by the General Committee. In the absence of any such reduced rate, Retired Family Members shall pay the same annual subscription and other fees determined and approved by the General Committee.

Draft Ordinary resolution for AGM #2

The Board of Directors and General Committee of the club propose that rule 3.25 relating to the complaints procedure be amended as shown below to clarify the process for arbitration

• 3.25 Complaints procedure



All complaints from Members must be in writing and sent to the Secretary with minimum delay. The Secretary will maintain all notes appertaining to the current complaint and present such details to the General Committee for resolution. The complainant may be invited to attend the said meeting

In the event that the complainant is dissatisfied with the outcome of the complaint the board of directors will appoint a suitable arbitrator whose decision the member may appeal for a further review by the club President, in which case the President's decision shall be final and conclusive.
